Clause 6.2 Classifications

Membership shall comprise the following classifications:

- (a) Individual – Available to all persons over the age of 18 years. This level of membership attracts an Individual Membership fee. In special circumstances, the Club may grant Individual Membership to a person under the age of 18 years, but they shall not be entitled to vote at meetings.
- (b) Family – Available to single family groups comprising parents and immediate children. This level of membership attracts a Family Membership fee.
- (c) Associate – At the discretion of the Executive Committee, this level of membership may be made available to:
 - (i) groups (including other motoring organisations, motor dealers and other relevant commercial enterprises etc.) who support the Aims and Objects of the Club
 - (ii) individuals, who, for various reasons (including geographic isolation, incapacitance, non-ownership of a Citroën vehicle, or no longer driving), is not able to participate fully in the affairs of the Club but who maintains an interest in supporting the Aims and Objects of the Club. This level of membership attracts an Associate Membership fee
 - (iii) Juniors, ie individuals who have not currently attained the age of 18 years.
